A fine of \$100.00 will be assessed on a stock contractor who was a NIRA member the previous year and does not pay dues 30 days prior to the first performance of their first contracted rodeo of the NIRA year. NIRA publication is available for \$10.00; NIRA belt pins are available for \$10.00 each.
- Rodeo personnel may purchase NIRA accident insurance coverage. Medical insurance provided by the NIRA is excess over any valid and collectable insurance. **Cost is \$145.00 per person.**
